## Who We Are

Established in 1991, as an affiliate of the Global Institute of Internal Auditors, the Bahamas Chapter of the Institute of Internal Auditors ("IIABC") is the local professional association for The Bahamas and The Turks & Caicos Islands, that supports the educational development and advancement of the practice of Internal Auditing. In 2022, the Central Bank of the Bahamas issued its Internal Audit Guidelines for Internal Auditors and Audit Committees, of which the IIABC was a primary contributor. The guidelines set out the minimum standards that SFIs are expected to adopt. We have more than 80+ active members in the chapter and 200+ professionals throughout both the private and public sectors working in various areas including internal auditing, risk management, governance, internal control, information technology auditing, education, and security.

## What We Do

The mission of the IIABC is to be the local voice, chief advocate, and principal educator on internal auditing in The Bahamas and the Turks & Caicos. In order to accomplish this, we offer three learning sessions during the year, (for members and non-members), and two membership socials. Additionally, we circulate a quarterly newsletter to our members with upcoming events and pertinent chapter information and also oversee the student arm of the Chapter located at the University of the Bahamas.
