


#### **CIA SCHOLARSHIP WINNER 2024**



# My Journey to the Certified Internal Auditor Designation


It was truly a journey—one filled with highs and lows, but also with growth, determination, and purpose. I want to first express my sincere gratitude to God for his many blessings, and to my rock, my dear wife, Mrs. Jacqueline Craigg-Andall, whose unwavering support carried me through this challenge.

In 2022, I believed the CIA Challenge Exam was my fastest route to certification. Balancing life, work, and other priorities, I diligently prepared. I took the exam through the PearsonVue System, finished it, and nervously checked my results—only to find that I had missed the pass mark by mere single digits. I was crushed.

Fast forward to 2023. After taking a break from the CIA program, I once again prepared for the Challenge Exam. I gave it my all, determined to succeed this time. But when the results came, it was another marginal fail. This time, I was completely gutted. I began to question whether the CIA designation was even for me.

But in those moments of doubt, I sought guidance. Conversations with key mentors and other professionals including Mr. Randy Marcano, and Mr. Justin Smith helped me regain focus. After deep reflection, I decided to abandon the Challenge Exam and instead take the longer route—completing the CIA the traditional way, part by part.

And that's where the story shifts! In March 2024, I began serious preparations for CIA Part 1, and by May 2, 2024, I passed. Energized by this success, I immediately moved on to Part 2, sat the exam on August 19, 2024, and passed again. Driven by my commitment to achieve the full CIA designation, I didn't stop there. I poured my efforts into preparing for CIA Part 3 and, on November 11, 2024, I passed that too.



Moral of the story:

"The race is not for the swift but for those who endure to the end.
Keep pushing forward— you've got this!"

To all CIA aspirants, my advice is simple: Stay focused and persevere. Once you put in the work and practice, success will follow. The achievement of this milestone will leave a lasting impact on your life, your professional growth, and your opportunities to connect with a global network of auditors.


