## **Academic Relations News**

#### 2025 Intercollegiate Ethics Case Competition

On February 28, 2025, The Northeast Ohio Chapter of the Institute of Internal Auditors (IIA) sponsored the 7<sup>th</sup> Annual Intercollegiate Ethics Case Competition (IECC) hosted by Cleveland State University. The annual competition features accounting majors from universities across Ohio competing to solve real-world

ethical dilemmas. This year's case was the original work of CSU Accounting Department Faculty Dr. Craig Foltin. It challenged students to think critically about the implementation of QC 1000 – the new quality control standard for public accounting firms adopted by the PCAOB.

Each of the eight competing teams showcased their talent by submitting a paper in response to the case and making a presentation in front of judges. **Baldwin Wallace University** took 1<sup>st</sup> place in the competition and **Kent State University** finished in 2<sup>nd</sup> place. Both teams presented in the final round showcase in the main auditorium after winning their opening round brackets. The runners-up in each opening round bracket, **Case Western Reserve University** and **John Carroll University**, were awarded a share of 3<sup>rd</sup> place. Each team received a cash prize.

Judges for the event included Northeast Ohio IIA Co-President Nick Jorz (Medical Mutual), Northeast Ohio IIA Past President Melissa Banfield (AmTrust), Michelle Buckley (Meaden & Moore), Gino Scipione (Cohen & Co), Tim Porter (Pease Bell CPAs), Steven Siemborski (Deloitte), Sam Strano (Deloitte), and Janis Thiedemann (Parker Hannifin).
