Chapter Beginnings:

It's hard to imagine, but it has been 75 years since the Oklahoma City Chapter of the Institute of Internal Auditors, Inc. was established. On September 1, 1949 an initial group of 18 internal audit professionals founded the local chapter, passed the by-laws and elected the original officers and one governor.
